**22/02162/FUL Sandhills, Cabbage Lane, Horsington** – proposed exchange of Residential Land with Agricultural Land and a formation of parking spaces. – **No objections notified 14/09/22** 

**22/01814/HOU & 22/01815/LBC 43B Cheriton Street, South Cheriton** – demolition of existing extension and erection of new single storey extension – amended plans to remove 1 window from the north elevation of the proposed extension and to add 1 window on the south elevation and to include the provision of a native species green roof. . – **No objections notified 14/09/22** 

**22/02519/S73A Solar Site At Sutor Farm Moor Lane Wincanton Somerset** - Construction of a 9.3 hectare solar park with associated works. S73A application to amend condition 2 of approval 14/05472/FUL (as varied by 16/03675/S73A) to remove the time limiting element for the solar site of 30 years from the approval date, which will allow the permitted solar installation to continue in perpetuity.

**22/02448/FUL : The Hollies Cabbage Lane Horsington Templecombe** - Erection of fence **22/00167/HOU : Rookes House Church Lane Horsington Templecombe** - Convert existing garage and reconstruct detached single storey stable outbuildings to form residential annex and convert former trailer store to double garage for Rookes House.
